


### PART 1 CRIMES 2020-2021

Part 1 Crimes are the universal standard upon which crime is measured in the United States. Part 1 Crimes are comprised of the following offenses: homicide, rape, robbery, assault, burglary, larceny, and auto theft.

The chart below depicts the criminal cases reported in North Fair Oaks from January 1 and until March for both, 2020 and 2021. The comparison will show the trend in criminal activity in the area and will also review the potential influence of the Covid-19 pandemic and its repercussions.


Despite the current global situation due to the Covid-19 pandemic; our mission remains to provide professional law enforcement services to unincorporated area of North Fair Oaks area.

#### **CRIMES AGAINST PEOPLE**

#### **HOMICIDE**

A homicide was reported in the North Fair Oaks area for the first time since 2014.

#### **ROBBERY**



We have experienced a decrease by four cases from 2020 to 2021.


This represents a reduction of over 50% in robbery cases for one year.

#### **CRIMES AGAINST PEOPLE**


#### **ASSAULT**

We have experienced an increase by 11 cases from 2020 to the same period in 2021.

This represents an increase of 36% of cases for assault in the area of North Fair Oaks



#### **RAPE**




We have had a reduction in cases reported regarding rape that went from 4 cases to 3 cases from 2020 to the same period in 2021.

It is important to mention that most of these cases didn't happen during this period of time, but were reported at this time.

#### **BURGLARY**


RESIDENTIAL AND COMMERCIAL




We had a a slight increase in residential burglary cases in North Fair Oaks with 1 additional case for 2021. Commercial burglaries had a reduction of 1 case from 2020 to 2021.

#### **LARCENY**

We had a total of 23 Larceny cases in 2020 and 45 in 2021. This represent an increase by 22 cases in comparison to the previous year.



#### **VEHICLE THEFT**



We have seen a slight increase in vehicle theft cases from 2020 to 2021.

21 additional cases occurred in 2021 in comparison to the same period from 2020.

The potential reasons for the spike in auto crimes include drivers staying at home and criminals taking advantage and looking for crimes of opportunity.

The pandemic and Stay-at-home order has impacted the crime tendencies in the unincorporated area of North Fair Oaks. Some types of crime rose during the pandemic, though overall crime rates remain historically low as of fall 2020.

These data suggest notable decreases in reports of robberies and rapes, a slight increase in assaults, and an increase in motor vehicle theft.

Commercial burglaries decreased by roughly 25%. The need to continue monitoring the new and identifying effective solutions remains high.

The crime rate in North Fair Oaks continues to be low. The Sheriff's Office continues to focus on addressing the challenging areas and evaluating on potential areas of improvement; while adjusting available resources to provide the highest level of service and professionalism to the residents of North Fair Oaks.


#### **COMMUNITY ENGAGEMENT**




































#### **CARON PROGRAM**

Many classes were streamed online, and contact was maintained with other local organizations to help our community during these times of uncertainty.


