I am requesting that the above-referenced item be deleted from agenda for the 7/8/17, meeting, and included as an agenda item for the 7/22/15, Planning Commission meeting. The bases for this request are as follows:

1. I calendared 7/22 as the meeting date for consideration of the item, and subsequently advised several interested Los Trancos Woods residents of that date.
2. On 6/24/15, I departed for a camping trip in central frontier Nevada, and did not return to my residence until the evening of 7/3/15. At that time, I became aware of the actual date.
